

The scripture reading will be given by my fellow Chaplain Reverend Charles Chalk, who is also Chaplain of the Department of Public Safety.


REVEREND CHARLES L. CHALK: Thank you. See what happens when a Catholic tries to put on a microphone! (Laughter)

REVEREND FOLEY: Please remain seated. The call to worship is in your program. It will be followed immediately by Hymn 548 in the hymnal.

"Give thanks to the Lord for he is good,

REVEREND FOLEY: "Remember us, 0 Lord in time of need."

PEOPLE: "Visit us with your saving help."

REVEREND FOLEY: Please be seated.

We were concerned when the ceremony began that the Pastor was detained for reasons beyond our control and that is exactly what happened and the reason it was beyond our control was that we started early. He was here on time and so here to give us the official welcome to The Federated Church of Sturbridge is the Pastor Reverend William D. Goble. Thank you.

REVEREND WILLIAM D. GOBLE: I was attending a wedding reception in nearby Charlton and I left right after the salad was served and I didn't get to have any of the main course, but I was glad to have an opportunity to be here and apologize for being late.

On behalf of The Federated Church, here in Fiskdale in Sturbridge, I want to welcome all of you who belong to the New England Association of Fire Chiefs and also welcome members of your families who are here with you. I'm sure you are having a very interesting and worthwhile 69th Anniversary Convention and that you will gain much from it.

As I have thought about fire, It seemed to me that It was one of primitive man's great discoveries to discover fire. He discovered what fire could do. He could use fire to cook his meat and food. Previously he had to just butcher the meat and eat it cold. He could use fire to keep himself warm through the verities of climate, climate changes. And through the years mankind indeed had discovered that fire is a very useful thing. Under most circumstances and under proper control fire is one of God's gifts to mankind. Also, fire at the wrong time and at the wrong place can be very damaging to mankind. You know much better that I the kind of damage that fire can do: Houses burn down, buildings destroyed, people's lives lost, people seriously hurt. Fire can do great damage and to help prevent the damage that sometimes fires can do, we have Fire Departments, which you represent. We depend upon our firemen to help keep fire in its proper place so that mankind will not be hurt by it.

I saw in Life magazine just this past month about a man who was in a recording studio in Time Square in New York City and a terrible fire broke out in that recording studio and he was forced to go out on a ledge overlooking Times Square. And it looked as though he would probably have to jump to his death or at least have serious injury. But then one of the firemen of New York City appeared on the scene. He was lowered down to where the man was standing on the ledge and he was able to wrap himself around that stranded man in such a way that he was able to bring the man to safety.

I thought that was a wonderful story and picture of how we have become dependent upon firemen. We owe you a great deal and it distresses me that in many communities nowadays because we are struggling with tax problems and with a lowering of incomes for our local communities, that we are having to let firemen go. We are having to relieve them of their duties and I think that is a very serious mistake because that leaves our communities not as well protected as they should be. I know that none of us likes to pay taxes but when the problem of paying taxes gets so we have to let school teachers and policemen and firemen, let them go, then It's time for us to realize that taxes, although unpleasant, nevertheless are one of the duties of good citizens and so I hope that all of us who are sits of our various communities will feel challenged not to say No to taxes but to do our best to see that tax money is well spent and that we maintain the required and necessary level of police protection, school teachers, and most of all, fire protection.

So I welcome you tonight and assure you that the people of this church are very grateful for the work that our local fire people do all over New England and all over this country. Thank you.

REVEREND FOLEY: Thank you very much. Thank you very much for those welcome words, I assure you because I am certain everybody here this evening feels exactly the same way you do.

For the memorial address this year, it is a pleasure to introduce to you my new fellow Chaplain who appeared here on this podium officially for the first time last year and this year we are pleased to have him give the memorial address. The Reverend Charles L. Chalk, Chaplain of the New England Association of Fire Chiefs.

REVEREND CHALK: Thank you, Reverend Foley, I appreciate that.

Before I begin tonight my message, I would like to thank two gentlemen who are Chiefs and here tonight who I owe some credit to for several things.

First of all, Chief Steven A. LaDuke, who I started out my training with years ago in the mid-80s. My department sent me to a training session in his department where I received my training and I also thank him tonight for all the work and effort he put in his department and put in in giving me the basic training back when I was merely a Chaplain for a Fire Department and had no connection with the Fire Department other than to be their Chaplain and to be there for their personnel.

And today, to be a full-time fire inspector for the Town of Merrimack, I owe a debt to Chief Hall, who allowed me to be working with you gentlemen as a Chaplain for the New England Chiefs Association.

So I thank you both, gentlemen, for the actual help you have given me.

In the scripture I gave to you of Matthew, the Lord spoke in a parable. For those of you who don't fully understand the meaning of what a parable is, basically the best description you can give of a parable is nothing more than an earthly story with a heavenly meaning.

Jesus loved to speak in parables. Jesus loved to come down to the level of a normal human being and bring something out to them, to a person that showed that he was himself being able to communicate with them and being able to get the message across in a good way.

And so tonight in this chapter we see Jesus says the kingdom of heaven was likened to the grain of a mustard seed. Of all of the things that the Creator of this world could have picked out and chosen to speak about he picked one small insignificant item, a tiny mustard seed, that very, very tiny item.

I believe he picked that mustard seed out because of several reasons: First, I believe because where there's life there is growth. And I see this as the Creator saying and he speaks about this seed and he calls it the least of all seeds, but yet on the other hand he takes this small insignificant, least of all seeds and he compares it to the kingdom of heaven.

Heaven is like this, which seems to be an odd correlation between the two. It seems different he would do it and calling it out this way, that he describes it that way. If we think of the kingdom of heaven, it is the least of all kingdoms. The Bible describes it uniquely that way. The Bible says Jesus himself was rejected among men, he was not accepted as part of the earthly kingdom, he was not accepted as part of an earthly system here. He started out with a handful of simple, individual, ordinary men who he could trust. He pulled them together and called them his disciples and trained them and sent them out to do a Job.

And as we see that seed, let's take a look at its outward appearance. It's a simple seed was that simple, small—and if any of you are cooks and you know anything of the gourmet seeds, it's a very tiny, insignificant seed. If we were going out and get a container and use them in any recipe, if we spill a few of those seeds, it's not of any consequence. We are not going to get on our hands and knees to search for them that we spill as we're not concerned with those few seeds because they are so insignificant.

Why is such a small, insignificant seed elevated to such importance that Jesus speaks of that seed? I think because there is a vitality within that seed. Within that seed is an inward vitality. It is a seed it is not a stone. You pick up a stone and there is no life in a stone, but within that tiny seed is life. There's something down inside that seed that is very important and within that seed lies several things. There's life contained in that seed. There is also possibility contained within that seed. There is also unseen power contained within that seed, things that we don't ordinarily think about but Jesus said there is

something about the seed. That seed though, by itself, as we would hold it in our hand, would not be of any significance, it doesn't do anything, it doesn't show anything. That seed has to be planted and put under special conditions before it begins to mature and before it begins to do something. It has a hidden power and a fruitful innocence that is never seen until it is dried, until it is placed in the ground where it can be stepped on, where it can be rained upon, it can be frozen and thawed and heated and different conditions are placed upon it, and until that can be done this living seed does absolutely nothing. It just lies there, it's just simply a seed. The atmosphere that it is placed into is not favorable.

The world that we live in today is not a fovorable place for a seed. It is not a favorable place for a human being to live as we think of all the difficulties around us and all the trials we face. This is not a particularly favorable place to live, but yet as we look at that seed there is something inside it, there is a destiny in that seed that's placed in that seed that is specifically given to that particular seed, and that is not given to any other seed. And there is a destiny that is given to you and I that is not given to anybody else. You have a destiny in your life.

Jesus says that seed is taken and he takes it. A man sows it in his field. It is the least of all seeds, but when it is grown it is a greatest of all herbs, but it has to grow. It became eventually a tree, that tiny, insignificant tree eventually becomes that tree that is out there.

But why is that a parable? The Bible says that the kernel of wheat, when it has failen to the ground, it dies before it can give forth life. I say tonight to you that many times the things that you will do in your life will not be apparent until you have failen to the ground and so to speak as the mustard seed is the grain of wheat, we die that our life begins to show forth.

As we are here tonight and as we think of a memorial service and we think of those who have gone on before us to their eternal home, we think tonight, again go back to thinking of this tree, this tree that has now sprung up from an insignificant seed and what has it become. The Bible says it has become a tree so the birds of the air come and lodge in the branches thereof. It becomes something that is valuable, more valuable than the insignificant seed that was simply, "I've lost one on the floor, I really don't care because it's insignificant," but now it has become a tree and in the branches of that tree lodge the birds of the air, it has been for them a place of rest, a place they can go to, a place they can trust.

And so tonight, those who have gone on before us that are now quickened have now become the trees that we look back upon and the trees that we lean upon and we look at their lives and they are now significant to us.

We may think we are of little influence on this earth. We might think of ourselves tonight as simply saying, "We're just ordinary people doing an ordinary job." But tonight I believe that as we work and you gentlemen tonight as you go back to your individual towns and as you work and you labor your entire life, giving your life as a public servant to the town you live in, to the state you work in, you tonight are plowing the soil, you tonight are opening up the soil and preparing the soil for that seed to be placed in. And it may be that you never know what becomes of the planting of that seed. You may say when your life is done that you feel like you have accomplished nothing. But I submit to you tonight that like the mustard seed, It is what we are doing, it is the ground that we are plowing, it is the preparations that we are making for the future that are the most important.

Jesus himself, as he spoke in the scripture, was obviously speaking and he said the kingdom of heaven. Tonight we must consider what we are going to do in our eternal home. Where is our eternal home? Have we made the decisions that are necessary in preparations for eternity?

I encourage you tonight to make the proper preparation for eternity within your own soul, but at the same time while you are living here on earth, think of yourself perhaps like that mustard seed as significant. As important, as important as those who have gone on before us.

Our heavenly Father, tonight we thank you for the opportunity to open your word and to see the relevance of it. We thank you that you spoke to us in such plain and simple things as simple earthly stories with such vital heavenly meaning. I hope each individual tonight, whether it be man or woman, to prepare for their eternal home.

Let us pray. We thank you , Lord, for those who give so much in each and every day that they live. We thank you for the protection that these Fire Chiefs give to us. We mourn the loss of those who have gone on. Lord, tohight their seeds are planted, their trees are growing, though there will come a day when they will lodge, there will be people who lodge in their branches as the birds in the air did to seek comfort, to seek shelter, to seek what they need. Thank you for all you blessed us with that we ask it in your name.

REVEREND FOLEY: Chief Jenkins will now sing "The Lord's Prayer." ("The Lord's Prayer sung by Chief John P. Jenkins.)

CHIEF OTIS WYATT: We will have the reading of the "Firefighter's Prayer" and you are all urged, if you are so disposed, to follow along in unison. The prayer is on the back page of your program.

The "Firefighters Prayer."

When I am called to duty, God
Wherever flames may rage,
Give me strength to save some life
Whatever be its age.
Help me embrace a little child.
Before it is too late.
Or save an older person from
The horror of that fate.

"Enable me to be alert And hear the weakest shout And quickly and efficiently To put the fire out.

"I want to fill my calling and To give the best in me, To guard my every neighbor And protect his property.

"And if according to my fate, I am to lose my life, Please bless with your protecting hand, My children and my wife."

CHIEF MARTIN J. JORDAN: I would like to say a couple things. This year, with some sort of a new perspective that's come upon myself that I want to change and instead of just reading the names of our departed members, and it seem to always be the same—and I honestly owe this to Father Foley from last year—and whoever was at the Annual Meeting last year and we were discussing our attendance at the Memorial Service last year and honestly, I'm very pleased and proud of what I see this evening as that's twice the amount of people we had last year.

It's very important, No. I, and I think we are all here because we want to be, not because we have to be. But that comment Father Foley made has really stuck in my mind and of the world services and other services, we're here to honor our departed brothers. And the comments made last year—and I hope you would bring this back to our fellow chiefs and hopefully increase the attendance next year that it is worthwhile coming to a Memorial Service, It is very important. And as he said last year that "Some day someone standing up here is going to be reading our names at a Memorial Service."

There's no way around it. We are all members of this Association and some day that is going to happen, all of our names are going to be read from one of these pulpits. Just think about that. And as the Chief said, maybe it is not important—it is important, it's very important. We're here honoring our departed brothers and I think we should try to get the work out there and have an even greater attendance as each year goes by and we should be doing that.

It gives me great dismay to read the names of 14 departed brothers this year, the first one being an active Chief and our departed Second Vice President of the organization and that's Chief Kenneth C. Wagner, Cumberland Center, Maine.

I would also like to thank my wife Linda, who did a job on the preregistration and made it a lot easier. To Pat Wyatt, Pat and Carl Winslow, Lorry Jorsey, and Rosemary Dunn, and Jane Haber, they did a good job on the registration desk.

A motion to adjourn is in order.

RETIRED CHIEF GERARD A. CARLE: [Dracut, MA] If I may, do we have a count of the attendance approximately or will we have that in the Red Book?

CHIEF JORDAN: In the Red Book.

RETIRED CHIEF CARLE: In the Red Book.

PRESIDENT HEALEY: I don't believe we have a final tally in the Red Book.

RETIRED CHIEF CARLE: I would like to see what the attendance versus other, an increase or decrease?

CHIEF JORDAN: From what I can see from the receipts, last year's passes were 627, 362 for the first day and yesterday was a very good day and today we even suprised ourselves. So just by looking at the receipts, I haven't had a chance to tally it beyond last year's.

RETIRED CHIEF CARLE: But the day passes, if people that came?

CHIEF JORDAN: The preregistrants were down about 20.

PRESIDENT HEALEY: I might comment that eight people that were signed to come and register and I believe backed out because of the demonstration that was scheduled to take place here so we were down maybe 12.

RETIRED CHIEF CARLE: Just to get an idea, normally we have a report of what had happened and how many registered in the hotel and all that.

CHIEF MCCARTHY: And now I'd like to ask everybody to please stand and sing a happy birthday for our 100th birthday boy.

CHIEF FIRE MARSHAL GROTE: Friends and neighbors, no one in this whole world has received the highest honor that I have received, not only here but in the past month when they gave me that big celebration in my own city, my own town.

And I want to say one thing, God has been good to me, my friends have been good to me-your relatives have no choice. [Laughter] it's such a reward that I must say It time and time again, my wealth is surrounded in this room and the wealth I have accumulated through friendship. There is no amount that could of buy or take it away from me and I feel thankful to the Almighty God and no one man of won a ballgame without the support of others and it's been with the help of my friends and the help of the Almighty God that I can continue. I am serving my 79th year I don't know what the word retire is, to back off or quit. With the help of the Almight God and my friends, And I want to thank you from the bottom of my heart again and again and hopfully the Almighty God will watch over each and every one of us with that prayer of mine--where is Father Foley--and I say: May the good Lord watch and protect until we meet again and peace on earth to all the good women. [Laughter and applause.]

I'd like to explain one little thing that I haven't convinced my own bishop that it took me 100 years to add the women. And I want to say one thing and this is a true fact. At our own gathering of 500 people at Bishop Zapeda, he said, "Chief, you have added something to the prayer."

I said, "I didn't deduct anything," but I said, "Bishop, would you be here this evening if it wasn't for that good mother of yours, regardless of what your father had to do about it." [Laughter].

And the Bishop Says, "Let's change the subject." [Laughter]

PRESIDENT WENDALL M. MANSFIELD: [Stowe, VT] Congratulations.

CHIEF MCCARTHY: Now president Mansfield will give his acceptance. President Mansfield.

PRESIDENT MANSFIELD: Being from a small town in Vermont of approximately 3500 people, to me It's an honor to be elected President of the New England Association of Fire Chiefs, Incorporated.

I would like to first thank my wife Phyllis for supporting me in everything I have done in the fire service all the way. (Applause)

I would also like to take this time to thank my First Assistant Chief Eugene Touchette and his wife, and Delores Thurston, Past President Ernie Flanders and his wife Polly, who have been coming for years and they have given me full support and a few people you can't do without. [Applause].

It's been a long and I can't say It has been a hard road because I enjoy doing everthing for this Association.

Last but not least, I would like to thank the entire Vermont delegation who has been here every year, I think, I don't know as I have lost count. All of you from Vermont know who you are and a lot of you are here and too numerous to mention that I can't give their names and they have given their support.

And I will do the same as I have done for the last eight or nine years for the Association. I want to thank everybody. [Applause]

CHIEF MCCARTHY: Thank you, Chief Mansfield.

It is my pleasure tonight to introduce as a guest speaker one of the best friends of the Fire Service in the State of Connecticut, David J. Paige. David Paige is the Deputy Commissioner of the Department of Public Safety of the State of Connecticut and heads the Division of Fire and Building Safety. The division consists of the Bureau of the State Fire Marshal and the Bureau of the State Building Inspector. Having previously served as Connecticut's Deputy State Fire Marshal, he continues to play an active fire safety role, carrying out the day-to-day duties and responsibilities of the State Fire Marshal.

Prior to has appointment as Deputy Commissioner of Public Safety, he served as a career Connecticut state police officer for the past 24 years, reaching the rank of major and serving in a variety of command assignments.

Commissioner Paige is a graduate of the University of New Haven and has been affiliated with the volunteer fire service for over 30 years, having reached the rank of Chief in his department. Commissioner Paige serves on the Commission of Fire Prevention Control, the State Emergency Response Commission, the Fire Marshal Training Council, the Connecticut Fireman's Antiarson Committee, and the Arson Tip Award Committee and he has also been the Second Vice President of the Fire Marshals Association of North America.

! am honored tonight to present to you as our guest speaker Deputy Commissioner David Paige of the State of Connecticut. [Applause]

DEPUTY COMMISSIONER DAVID J. PAIGE: Chief Healey, Chief Mansfield, Reverend Clergy, honored guests at both head tables, ladies and gentlemen, good evening. Thank you very much for that kind introduction. It has been said many times that it's not so important that you write your own introduction. [Laughter]

Janet and I are very pleased to have the opportunity to take part in the 69th Annual Association of Fire Chiefs Conference. We've been attending these gatherings for the past 10 years. I started when I was a volunteer fire chief at the Apponimock Fire Department. And I look forward to the program each and every year but little did I know that some day I would be speaking to the membership of the Annual Banquet.

And strangely enough, in all those years I never attended the banquet, I always had other things to do. So I asked my friend, Father Foley, what I should say. And he gave me a couple of suggestions. He said, "First of all, select a topic that is current with today's events." And he told me to tell a joke. And I asked him how long I should speak and he says, "Well, make It about as long as the average fire chief spends making love. [Laughter] So with that point in mind, I will conclude my comments and take my seat. [Laughter and Applause].

Old Father Foley is quite a guy, isn't he? [Laughter] He tells everyone he is Irish but last night we had a couple of beers together and he finally broke down and said, "I'm half Irish and half Scotch," [Laughter] he says, "I love to drink all night but I hate to pay the bill." [Laughter].

Chief Grote is probably angry at me, picking on the good father but believe me it's all in fun and as a charter member I'm sure you delight in the growth and progress this Association has made since it's founding days.

I'm especially pleased to pay tribute and recognize Chief Healey from Milford, Connecticut, for his term of President of the New England Association and also to be one of the first to congradulate and welcome your new President, Chief Wendall Mansfield of Stowe, Vermont. Chief Healey has been very helpful to me personally and very supportive of the activities of the State Fire Marshal program in Connecticut, but did you know that we almost didn't make it here this evening? Bill and I had a little assignment to take care of, we had some business to conducts in a couple of towns over and we were rushing back to get back here at 6 o'clock and we got lost. And we're coming through this little back country town and Bill was rather nervous about the time and so was I neither one of us had a watch. And we pulled alongside to a farmer milking a cow and we pulled over and he gave us directions. "And by the way, do you have the time?" And the farmer, being a typical New England Yankee, sits on the stool and lifts up the cow's udder and lifts his head up and says, "It would be a quarter past 4."

And Bill says, "That's amazing! There's a guy can tell the time of day by lifting the cow's udder. We don't have that many cows in Connecticut."

And I asked the farmer how long has he been doing it and he said, " About forty years." "Would you teach me that?"

"Just sit yourself down on the stool, reach your hand out, put your hand on the udder, gently, and now lift that udder up a little bit, bend your head down slightly and just about now you should be able to see the hands on the clock tower." [Laughter and Applause]

In my position as the Deputy Commissioner of Public Safety and also as a member of the Executive Committee of the Fire Marshals Association of North America, I've had the fortune to travel throughout the United States and observe the state and local fire service organizations. While some areas have truly impressive operations and have made dramatic advances in fire safety, I can report to you that the New England area continues to maintain its long-standing leadership role.

New England's unique character presents special tactical problems to our fire prevention and fire suppression personnel: Large factories, narrow, winding streets, a long winter heating season, all factors which contribute to the fire loss rate in the region.

Despite these adverse conditions, however, the region has nonetheless witnessed the steady decline in the fire death rate. This is particularly true in my own state. Now, I realize it's not polite to stand before you and brag, but I think it's entirely appropriate that I pay tribute to the fire service personnel of the State of Connecticut who have done a remarkable job in making our state one of the safest in the nation and for that I'm truly proud of them and forever grateful for their efforts. And gentlemen and ladles as well, I took a lesson from your friend Chief Grote.

New England as a whole has developed some innovative fire safety programs and recently enacted a sprinkler ordinance in West Stockbridge, Massachusetts and originally the idea came from Egremont. It will be an interesting topic to follow.

Our own arsenic accelerant detection canine is believed to be the world's fully operational dog specially trained to sniff out accelerants, another tool in the firefighters' arsenal. We currently have two Labrador Retrievers, Matty and Solo, and have trained similar teams from throughout the United States, including Massachusetts and Maine.

This upcoming Fourth of July weekend brings to mind the hard fight recently won by the New Hampshire Fire Chiefs Association, who successfully overcame widespread roadside sales of dangerous firearms. A fine example of well-organized teamwork working toward a common public safety goal. Fireworks are spectacular but there is no doubt they are extremely dangerous, they're volatile and subject to unexpected premature explosion. They produce painful, maiming wounds and burn injuries. We as a group should not yield in opposition to the private use of firearms.

Despite significant advances of fire suppression and fire prevention, our region today faces perhaps our most demanding crisis yet, a depressed economy throughout the northeast, producing economic choas that has seen witness to stait on closings, fire prevention and fire education programs downsized and eliminated, firefighters laid off, and public safety budgets cut to unprecedented levels.

As administrators you must be responsible in your fiscal management, but at the very same time you are expected to insure the safety of the citizens is not compromised, creating a terrible stressful situation.

Tough economic times also impact on the fire service far beyond the budget. Arson for profit increases as a means of recovery for business or simply as a fraud and greed.

We see an alternative in heating devices by those less fortunate.

Excuse my cough. I had a friend who had a cough, he was in his neighbor's bedroom- [Laughter].

And perhaps the most long-term energy impact is the reluctance to comply with our fire safety code requirements. Unfortunately, it is during these difficult economic times that we hear the voices of those who oppose code administration, selzing upon emotions and speaking out against our most effective fire safety tool. What they say often fails upon sympathetic yet uninformed ears. Generally, those in official capacities, municipal leaders and legislators, we must always be on guard to defend our position and hold the line on fire safety. Fire safety is not periodic, it's not like the Dow-Jones index that goes up and down, fire safety is forever.

Let me shift gears for a minute. It has obviously been said that with adversity comes opportunity. As we attempt to do more with less, as we endure streamlined staffing and reduced programs and as we struggle to effectively manage our resources, it becomes important to develop a plan for the future.

We often say in the fire service that no plan is a plan to fail. To consider what you envision as an ideal organization, plan for it, do it now, do it today when we're operating

at the bare bones minimum. There is no better time than the present to dream of the design structure for the challenges that lie ahead. Our experts tell us and history has demonstrated that the economy will cycle back to a position near to what we call normal when the money and the resources become available again and it will only be those agencies that have worked out a method of accomplishment that will be successful. Will you be prepared when better times arrive again?

I know the coffee drinkers in the audience will appreciate the fact I am drawing to a close and if I could call upon the words of Henry VIII when he spoke to his many wives, "I'll not be keeping you long." (Laughter)

We have tightened our belts and we've hunkered down for the long haul. But as we endure this difficult period, I ask that you keep your goals and your dreams intact. Do not lose sight of the ultimate objective, that of protecting the public from the harmful effects of fire.

I realize it is easy to become discouraged,! go through this day in and day out. But whether you are a career fire chief or a volunteer chief, don't give up, think positive, don't allow these trying times to consume you. And above all, take care of yourself, you are our most important resource.

Now, I appreciate the opportunity to have come before you this evening and I would like to take one moment to tell each and every one of you and your spouses and your loved ones how much I appreciate the job that you do, how thankful I am of the job that you do and I believe the people that you serve feel the same way. Thank you and God bless. (Applause)

CHIEF MCCARTHY: Thank you, Commissioner Paige. And now you realize why he is so well-loved and liked in the State of Connecticut.

Now to take a page out of Chief Grote's book, for a couple of minutes I'm going to turn the program over to the women and I would like to call on Phyllis Mansfield for a presentation. Mrs. Mansfield.

MRS. PHYLLIS MANSFIELD: I would like to call on Marion. The ladies of the committee would like to thank you for all your help and support. (Applause)

(Mrs. Mansfield presented gift to Mrs. Healey.)

MRS. MARION HEALEY: Thank you very much. [Applause] I want to say thank you to every one of you and it's been one of the most enjoyable years I've had with all the cooperation of the ladies and I've had an enormous amount of fun doing it. I hope all the ladies that came enjoyed the program we put on for them. Thank you very much.

CHIEF MCCARTHY: And now Mrs. Amy Jordan will make a presentation. Amy Jordan.

MRS. AMELIA JORDAN: Marion and Phyllis, I would like to present these two women with these gorgeous bouquets. It was an excellent year and we had a lot of fun.

You were great to work with, Phyllis, and we're really looking forward to another banner year.

[Applause as bouquets are presented to Mrs. Healey and Mrs. Mansfleid.]

CHIEF MCCARTHY: Now for a presentation, I would like to call on Jane Haber-

MRS. JANE HABER: Thank you, Mr. Toastmaster. Mr. President, Mr. Ex-President, guests at the table, and all the people at this banquet this evening.

Our President's wife Marion is someone special. Marion, you made it very difficult for us to give something to you, something you do not already have. MRS. HEALEY: I will. Thank you again.

CHIEF MCCARTHY: Bill, better be careful, when he retires it will be tougher on the house. I received a proclamation from Frederick Lissman, the mayor of the City of Milford.

FIRE MARSHAL PETER F. PHELAN: Chief, I thought Maurice was going to do this. As your support staff we present you a little token of our appreciation. This is for your service as President of the Association and also for 18 years as Chief.

[A clock presented to Chief Healey.]

CHIEF MCCARTHY: Commissioner Philip Ucci of the Board of Fire Commissioners, City of Milford. Connecticut Commissioner Ucci.

COMMISSIONER PHILIP UCCI: Chief, on behalf of the Milford fire community of the City of Milford, I would like to present this plaque to you which reads:

CHIEF HEALEY: Thank you.

CHIEF MCCARTHY: I am honored and happy to call on a dear and old friend of mine, outgoing President William Healey for his farewell address. Outgoing President William A. Healey. (Standing ovation)

CHIEF HEALEY: Reverend Clergy, officers, directors, guests, all. I'm not known for long speeches and it's not going to be very long tonight. I only am going to thank a few people. Now I have all these proclamations here and awards, I would like to thank the officers and Directors this year. It isn't the year that makes the success, it's the committee, the Directors and the officers. They all work very hard to make this conference and the year very successful.

I'd be remiss if I didn't thank Eddle and Jane Haber, the Director from Connecticut. Ever since I was made Second Vice Eddle has been Director and he's been supportive. He does the legwork. And what he doesn't do Jane does for him. They've been of tremendous assistance to me and Marion and I want to thank them personally, Jane and Eddle. [Applause]

I would also like to thank the speaker tonight, Commissioner Dave Paige. Dave said i've known him a long time but I thought his speech hit it right on the nose tonight. We're at that point where we either sink or swim and I think we're going to swim if we do our job right. Dave, thanks for the wonderful words. [Applause]

And of course, Maurice McCarthy, the MC. I wasn't here when he was introduced in the beginning, but he's the Chairman of the Fire Prevention and Control Commission of the State of Connecticut. Maurice has been around half as long as Jim Grote and it goes way back to the Wentworth days. And when I asked him if he would MC tonight, he was more than happy. We gave them an area to do that with the TV cameras. They came down and they put down their demonstration. They were professional, they were courteous, and I think they did an outstanding job about disrupting the Conference. [Applause]

In spite of all this, it's been a very successful year, a super-super Conference and it's been my honor and privilege to be your President for this year. I want to thank you very much. [Standing Ovation].

CHIEF MCCARTHY: Thank you, President Healey. Connecticut especially and all New England is certainly produced of the year that you were the President. We're most grateful for everything that you have done.

And now I would like to call on Reverend Charles L. Chalk of Merrimack, New Hampshire, Chaplain of the New England Fire Chiefs Association for the closing prayer and benediction. (Everyone stood)
